Applicable test standards in the Interpretation of New ordinance specifying Technical Requirements for Electrical Appliances

1. Please be informed that the descriptions of the test standards under Electrical Appliances and Materials Safety Law have been changed as of January 1st 2014.

Previously, the test standards on each application form related to Conformity Assessment used to be expressed as "Ordinance 1" or "Ordinance 2".

However, under the new regulation, the division such as "Ordinance1" or "Ordinance2" was abolished, and the test standards to be applied have been updated to Appendixes, shown as follows.
